

Fishing regulations for the Rauschelesee and the upper Spintikteich

1. This permit is only valid in conjunction with the official fishing license and is not transferable.
2. The catch limit is 1 pike, 1 zander and 1 carp per day. Carp over 5 kilograms must be released.
3. A maximum of 2 fishing rods may be used at the same time. The fisherman must always be present when fishing. Be present at all times.
4. With the exception of the pole fishing rod, all fishing gear such as nets, fish traps, night lines, etc. are PROHIBITED. ARE FORBIDDEN.
5. All licensees are advised to report any perceived violations of legal and internal regulations to the nearest supervisory body or the municipal office. This also applies to water pollution and the occurrence of fish diseases (fish mortality).
6. Immediately after catching a fish, the licensee must enter each fish caught in full in the catch list using a ballpoint pen. The catch list (fish species, length, weight).
7. Fishing is only permitted at the declared fishing spots.
8. Fishing is generally prohibited in the municipal bathing area from May 15 to September 15.
9. Fish caught during the closed season or below the minimum size must be returned to the lake immediately and carefully. If the hook is swallowed deeply, the fishing line must be cut off in front of or in the mouth of the fish and the fish carefully returned. carefully release the fish. Fish that are no longer viable must be cut up and thrown into the water as food into the water as food. Sick fish must be removed from the lake regardless of the closed season and minimum size.
10. It is prohibited to keep fish that have to be released.
11. The use of live vertebrates as bait is prohibited. Dead bait fish only with single hooks.
12. Fish from other waters may not be used as bait in Lake Rauschelesee and Spintikteich.
13. The permit with the catch list must be handed over to the supervising fisherman during the inspection and, if requested, the fish caught must also be handed over for inspection. fish caught must also be presented for inspection upon request.
14. The supervising fisherman must - without prejudice to the subsequent statutory right of appeal - be obeyed in matters relating to fishing of the fishery.
15. It is the duty of all fishermen to behave in a collegial and helpful manner when sport fishing, to keep the fishing area clean and not to litter. clean and not to leave any waste behind. Open fires are strictly prohibited.
16. The municipality of Keutschach am See requests that you, as a fisherman who is respectful of the game, in the interests of the fish population (development of fish species, biological balance) to keep the catch list conscientiously.
17. When a new permit is issued, the expired permit with catch list must be handed in (GH "Maria", owner Manuela Okorn or the municipal office).
18. In addition to the legal provisions, the guidelines of the fishing regulations also apply to the practice of sport fishing. fishing regulations. Any violation of these regulations will result in the immediate withdrawal of the permit without compensation. without compensation.
19. Fishing with treble and twin hooks is generally prohibited (with the exception of spoons and wobblers).
20. Fishing and casting with drones is strictly prohibited.
21. Fishing with boats is not permitted at Spintikteich. Boats are only permitted on Lake Rauschelesee with written permission. You may use inflatable boats that you have brought

yourself. Electric motors are prohibited. Fishing and boating is prohibited in the designated protected areas.

22. Only bait suitable for fishing may be used. Dog food such as Frolic and the like are strictly prohibited.
23. Fishing without an unhooking mat is not permitted and will result in the permit being revoked. All fish caught must be fed on the unhooking mat.
24. Sufficiently sized landing nets (min. 100 cm) must be used for carp fishing.
25. Caught fish (carp) may only be kept in sufficiently large carp bags (individually) in deep water. be kept in deep water.
26. The fishing list (which must always be kept up to date) must be completed in full by the fishermen (incl. the released fish such as carp, undersized pike, zander, etc.) by 31 October at the Keutschach am See municipal office by 31 October (municipal letterbox or by e-mail to: info@keutschach.at).
27. Gutting and scaling fish on the water is prohibited.
28. Feeding the fish (carp) is permitted with a maximum of 0.50 kg per fishing day.
29. Fishing is only permitted at casting distance.
30. Deviations from the above regulations will be announced separately and in an appropriate manner. Failure to comply with the above regulations will result in the immediate withdrawal of the fishing license.
